ELIGIBILITY: This competition is open to all competitors born in 2004 or later. All com-

petitors must be individual members of USA Shooting.

RESIDENCE: Each competitor may claim residence in only one state and must declare the

state of residence on the entry form. Residents are eligible for the 1st, 2nd and 3rd place USA Shooting State Champion medallions. Residency is defined as to where the competitor holds a current and valid driver's license. If the competitor does not have a drivers license, residency is then defined as to where the competitor's parents/guardians reside. Non-

residents may compete for invitations to the National Championship and are

encouraged to do so. Non-residents are not eligible for state awards.

ENTRY:

Only scores from a registered State Junior Olympic match will count for invitation to the National Junior Olympic Championships. Shooters <u>may</u> <u>not</u> compete in more than one state JOSC. Juniors who fire in their own home state JOSC will not be allowed to shoot in another state. Juniors from states which are not holding a state JOSC, and those who cannot attend their own state JOSC, will be allowed to enter as a non-resident in another state. Non-residents should declare their home state at entry and are not eligible for state resident awards.

Residency is defined as to where the competitor holds a current and valid driver's license. If the competitor does not have a drivers license, residency is then defined as to where the competitors parents/guardians reside.

CATEGORIES: The following categories will be used for the competition:

Based on the age the competitor will be on the first day of competition. Competitors under 21 (U21); competitors under 18 (U18); competitors under 15 (U15).

RULES: <u>THE CURRENT ISSF RULES WILL GOVERN</u>

COACHING: Coaching on the firing line will **not** be permitted.

SCORING

PROTESTS: A scoring protest of \$1.00 per shot may be charged.

TIES: All ties will be broken in accordance with ISSF Rules.
