

Steamboat Challenge NRA Action Pistol WY State Championship

Despite a chronic ammunition and reloading component shortage, 38 NRA Action Pistol competitors converged on the "Capital of the Old West" Cheyenne, Wyoming for the 7th "Steamboat Challenge" NRA Action Pistol Wyoming State Championship conducted on Aug 22 at the Otto Road Shooting Range.

"Steamboat Challenge" pays homage to Steamboat, a legendary Wyoming bred bucking horse from over 100 years ago. Known as "the horse that couldn't be ridden," he is the iconic Bucking Horse and Rider logo of the State of Wyoming.

Steamboat Challenge lived up to its name during match weekend. The Otto Road Range is at 6,600 feet altitude on the high plains of SE Wyoming. Along with the altitude there is a tendency for very high winds. Although it's been a mild summer in Wyoming, a strong cold front moved through the area before the match resulting in gusty winds all weekend. Undeterred by the difficulty of shooting under windy conditions, some excellent scores were posted by the shooters in all divisions.

The State Championship match consisted of four shooting events, each one testing a competitors skills in many different ways. The Moving Target (Modified) Event requires a shooter to engage an NRA AP1 target moving at 10 feet per second for 60 feet. Distances are 10, 15, 20 and 25 yards. The Barricade (Modified) Event requires a shooter to engage an AP-1 target from strong and weak side of the barricade with a mandatory reload under time pressure. Distances are 10, 15, 25 and 35 yards. The Falling Plate Event requires a shooter to engage six 8 inch steel plates which fall down when hit under variable time limits. The International Rapid Fire (Modified) event is similar to the Olympic event with five NRA B37 targets and all shooting done at 25 meters with shooting stages of 8, 6 and 4 seconds. A total of 174 shots fired with a maximum possible score of 1740-174X.

We were pleased to have Cheyenne Mayor Patrick Collins stop by the range and hand out awards after shooting was completed.

Seiichi Ishikawa of Montebello, CA was State Champion with a score of 1693-104X
Second Place went to Rob Vadasz of the US Border Patrol with a score of 1682-108X
Third Place went to Joey DeLeon of the US Border Patrol with a score of 1665-117X
Fourth Place went to Andy Rayland of Cheyenne, WY with a score of 1662-108X

Junior Champion was 14 year old Bridger Steege of Cheyenne, WY with a score of 1659-106X
